Extinguishing media

Enhance Lemongrass

Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapours. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Avoid discharge to the aquatic environment.
